Transferring an Existing Certification

Unhappy with your current Certification Body? DEKRA can transfer your certification in a short period of time. For most standards, including ISO 9001 and AS9100, there is no cost to transfer to DEKRA!

A company may transfer Certification Bodies anytime in the audit cycle. It is not necessary to wait until the current certificate is near renewal. The process is very simple:

> Off-Site Transfer Review

DEKRA will request the client to submit a copy of the current certificate, previous cycle audit reports from the previous registrar, and a copy of any non-conformance closures, if applicable, for review.

> Transfer Audit

An audit will then be performed for the upcoming event (renewal or surveillance) in line with your current schedule.

> Issuance of New DEKRA Certificate

DEKRA will issue a new certificate with your current expiration date within one to two weeks of the transfer audit.
